**STALLION :**                    **DC WT LIGHTENING    Q-56811**

**1. NATURAL SERVICE :**

This is \$990 per mare, \$300 booking fee, non refundable but deductible.

**2. AGISTMENT FEE :**

This is \$8 per day for dry mare, \$10 per day for wet mare.

Hay is included in day rate, if any other diet is required we are more than happy to feed it to your mare but must be supplied by owner.

**3. FEES :**

The breeding fee and the agistment fee as well as any veterinary fees must be paid before removal of your mare(s) from the premises.

These fees are not refundable.

**4. SHIPPED CHILLED SEMEN :**

This is \$990 per mare, \$300 booking fee, non refundable but deductible,

The stallion service fee, shipping fees, semen transporter container deposit (If applicable) are to be paid in full, a breeding contract signed by both parties and a copy of mares papers(if applicable) must be given to the stallion owner before semen is shipped.

**Payment for collection must be paid by mare owner directly to nominated vet.**

**Nominated vet is:**

The stallion owner will ship the semen to the mare owner the fastest way possible.

Transportation of the semen will be selected by the stallion owner,

Unless otherwise arranged.

**NOTE** Some carriers do not ship on Sundays.

**If a positive pregnancy does not result first time,**

**Stallion owner will re ship fresh chilled semen at no extra cost,**

**However collection fees paid directly to nominated vet still apply.**

**If again mare does not settle,**

**a handlers fee of \$200 is to be paid to the stallion owner,**

**plus collection fees paid directly to the nominated vet still apply.**

These fees are not refundable.

**5. NATURAL SERVICE PREGNANCY VERIFICATION :**

The mare(s) shall remain under care, control & custody of Dry Creek QH's for the agistment fee specified above until ultra sounded in foal by our veterinarian at 16 days after last serve, if not in foal, mare shall be rebred at next cycle.

## **6. BREEDING CERTIFICATES:**

A certificate will be forwarded to the mare owner, once the AQHA has issued them to the stallion owner, any breed other than Quarter Horse will get a written certificate to give to their breed association.

## **7. 30 DAY LIVE FOAL GUARANTEE:**

This guarantee means that a viable foal resulting from this mating will stand and nurse and live for 30 days, or mare may be returned for re servicing at no additional breeding fee charge:

**However a \$200 handlers fee does apply, agistment and vet fees will also apply to natural served and collection fees to be paid to nominated vet still apply for AI.**

A letter from mare owners' veterinarian must be furnished as proof of death of the foal if the mare had delivered a foal that lived less than 30 days.

Mare owner may substitute another mare to the above stallion if agreed upon by stallion owner.

## **8. HEALTH REQUIREMENTS OF MARE:**

Any mare to be bred must be accompanied by a letter from mare owner's vet Certifying the mare is free from infection.

## **9. VETERINARIAN CARE AND FEES:**

Mare owner(s) agree that, if necessary to enhance a successful conception, the stallion owner may at his or her discretion, have all reasonable and customary needed veterinary reproductive work on their mare.

**All veterinary fees are to be paid by mare owner before mare leaves the premises.**

## **10. NON TRANSFER STATEMENT:**

This contract shall not be assigned or transferred by you and in the event the mare is sold, notification must be given to Dry Creek QH's for approval to transfer the contract to the new owners, Dry Creek are under no obligation to transfer contract to the new owners, with no refund due from the stallion owners.

Booking fees are not refundable under any circumstance.

## **11. LIABILITY STATEMENT:**

All mares and foals will be given careful treatment and handling.

However the owners of any mares or foals in our custody and care hereby waive all liability claims for injury, disability or death suffered to mare or foal, as a result of acts by Dry Creek QH's, its employees, owners or family, excepting intentional acts and acts of gross negligence.

This contract is executed in duplicate and the same shall be binding upon both parties when accepted by you, the mare owner and signed by both the mare and stallion owners.

## **12. STALLION AUCTION SERVICE**

If you purchased a service to DC WT Lightening via a stallion auction, whether it be a natural service or AI, it is only valid for the breeding season in the year you purchased it, the serviced cannot be carried over to another year for any reason.

We will require notification from the auction management to confirm all fees have been paid in full before semen can be shipped or natural service booked.

**Vet and agistment fees apply to natural serve, collection fees apply for AI.**

**All rules and rates as per above.**
